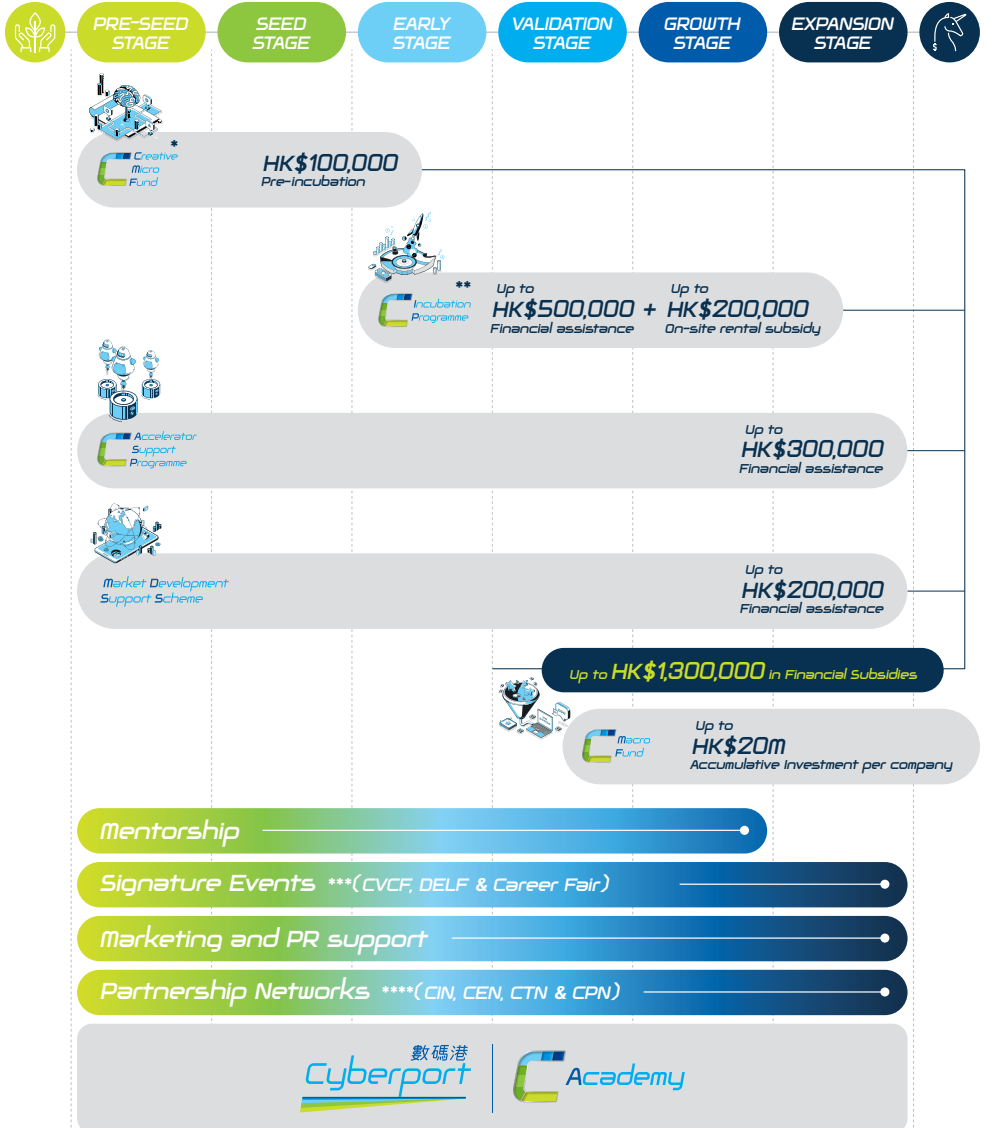

Through a bracket of targeted incubation programmes, Cyberport caters specifically to priority needs for entrepreneurship in different development stages, ranging from talent training, seed funding, go-to-market assistance to investor matching:

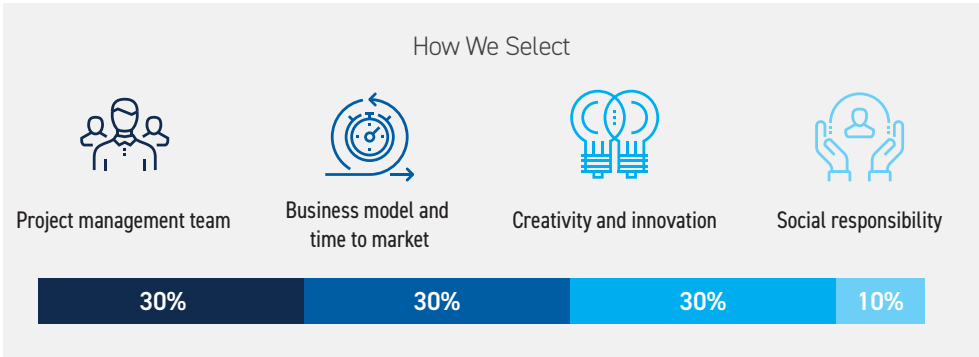

Vetting Criteria and weighting

HK\$10,000 upon signing of CCMF Agreement by both recipient and Cyberport



HK\$45,000 upon approval of the Recipient's Interim Report



Remaining **HK\$45,000** upon completion of the Project and approval of the final report



Cyberport Incubation Programme, including Cyberport Incubation Programme for Smart Living Start-ups

Up to **HK\$500,000** and **HK\$200,000 on-site rental subsidy**, financial assistance, professional advice and strong networks to accelerate your business growth over 24 months

Eligibility

- A registered digital tech company limited by shares and incorporated in Hong Kong less than 7 years (or in progress of incorporation) upon application deadline
- A viable business plan with product / solution ready for marketing in 12-18 months
- Founders collectively must hold at least 51% of the company shares or have absolute control
- All Incubatees shall maintain local presence with at least one local authorised representative physically working in Hong Kong (mainly to support local operation and product development) in the incubation period. Such a representative shall be either a Founder/Co-founder or a local full-time staff employed by the Incubatee

Market Development Support Scheme



The Market Development Support Scheme (MDSS) reimburses Cyberport incubatees, grantees and alumni up to **HK\$200,000** for expenses* to expand their businesses to the Mainland and Overseas markets.

Four scopes of Market Development Activities for Overseas/ Mainland Markets are covered:

- Delegation mission to Overseas/ Mainland
- Marketing exhibition/ conference/ event
- Landing service for Overseas/ Mainland market expansion
- Online/ offline marketing services for Overseas/ Mainland market expansion

*The reimbursable percentage is up to 75% of eligible expenses.

Eligible reimbursable items include[#]:

- Programme or exhibition fee
- Training as professional landing service
- Live streaming service
- Placement of online/ offline advertisement service
- Video production service (corporate branding or product promotional videos)

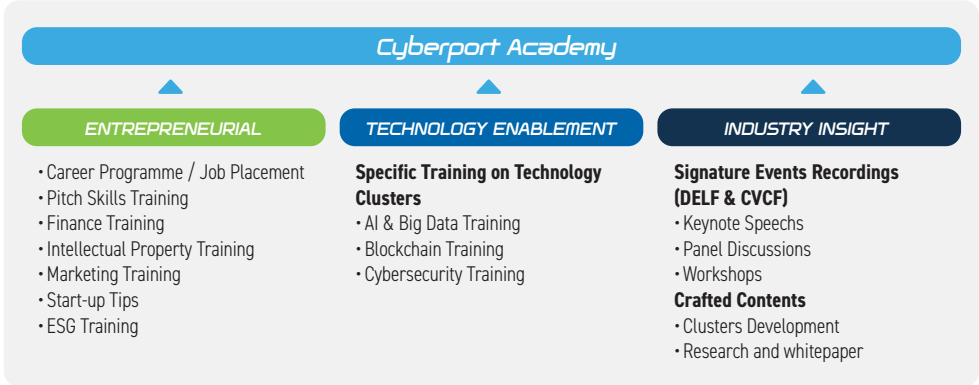
SCALE UP
